



## Applying for Membership

### Information

Membership can be attained when owning a property within the geographical area of the Association, according to the statutes of the Association. If a property is owned by numerous individuals only one individual can be a member of the Association.

An application for membership is to be sent to the board of the Association for processing.

Acceptance of new members is ongoing, and until the establishment of the original optofiber network has been completed also applications for new connections may be accepted. In November, 2020 this was estimated to be reached by beginning of 2021. Once the original network has been completed, notifications of interest for additional property connections will be considered only when these reach a high enough number to defend construction costs.

Until completion of the original network members are paying the membership contribution for the property connection where construction work is still ongoing. When construction work has been completed in the area, members would pay both the contribution for connection *and* the construction costs for additional work needed for the connections.

According to the statutes members are obliged to inform the Association of updated contact details. Members are also obliged to pay fees and contributions according to statutes and decisions made at annual general meetings.

**The membership contribution** of SEK 100 per property is a unique contribution and is to be paid together with the signed application. This is a basic contribution per property to the Association but not a part payment for a connection. This contribution is refundable upon exiting, or expulsion from, the Association.

**The membership fee** is a yearly fee which is decided at annual general meetings, and for the year 2021 the fee is set at SEK 250 per member.

A new member applying in the year 2021, is requested to pay SEK 1350 as the membership fee for the year 2021 *and* the accumulated fees for the years the Association has existed add up to this amount – in solidarity all members pay the fees for all years of existence of the Association.

If the property in question previously has belonged to a member and is being transferred to an incoming member, yearly fees have already been paid during the years of ownership and thus

the above does not apply. The incoming member is thus only obliged to pay the fee for the actual year.

**Membership fee/s and contribution/s, are to be paid** to the bankgiro of the Association, 578-1307; in 2021 in total SEK 1350 for a new membership, *or* SEK 250 for a new member with a transfer of property designation with connection and all fees and contributions already paid. Please add the property designation and name of member for the payment.

Seller and buyer are advised to use the Agreement of Transfer (Överlåtelseavtal) to inform the Association of the transfer of property.

**Member contributions for connections** has been set at SEK 20 000 per connection and was to be paid by March 2020 by all members of the Association. Final costs per connection will be regulated only by the finalisation of the establishment of the original network, foreseen to be realised in 2021. Contributions for connections are to be understood as investments in properties and are not refundable whether the optofiber has actively been used or not. Contributions for connections are to be paid to the bankgiro of the Association, 578-1307, please add the property designation and name of member for the payment.
